


ESTIMATED INVESTMENT PORTUGAL AND SPAIN

Estimated investment volumes H1 and YE for 2023 (in EUR million)



PRIME YIELD ADJUSTMENTS IN 2023






PRIME RENT ADJUSTMENTS IN 2023






CA PATRIMÓNIO CRESCENTE

Dispersion by country






CAPC AMONG TOP PERFORMING FUNDS OVER TIME IN IBERIA (MSCI)
